We wish to invite you to present a paper at the **N W U 3 rd CFML Conference**, which is held in person in **Swakopmund, Namibia from 25-27 October 2023. The registration is R2500.**

The theme of the conference is: **Towards Financial Inclusion in the Global Economies to Promote Socio-Economic Justice, Viable Financial Markets & Reputable Financial Institutions.** Accordingly, there is a great need for companies, policy makers, international financial institutions, governments, business persons, market participants and all relevant persons to promote financial inclusion, especially for the poor, vulnerable and lowincome earners in their respective countries and economies. As such, it is crucial for all governments, policy makers, business persons and all relevant stakeholders to adopt adequate policies, laws and regulations so as to compact all financial crime in global economies, businesses, financial institutions & financial markets to promote financial inclusion, socio-economic justice, public investor confidence, market efficiency & market integrity. The conference will provide a platform for academics, policy makers, market participants, students and other relevant persons to interrogate the aforesaid matters and hopefully come up with solutions in respect thereof.

The **sub-themes of the conference** include the following:

- challenges to socio-economic justice, social justice and the need to curb corporate inequalities corporate workplace
- the future of central banks, regulatory bodies, twin peaks, & other enforcement approaches in the banking, financial markets and global economies
- digital inclusion, CBDs, blockchain technology, virtual & cryptocurrencies, bitcoin and their related financial crimes
- trade diversion, trade finance, SMEs, MNEs & the future of international trade
- money laundering, insider trading, market manipulation & related financial crime regulatory challenges in the global economies and global financial markets
- artificial intelligence, financial technologies, digital assets, financial crime & the future of financial regulation & financial markets
- the role of IMF, World Bank, WTO and other international financial institutions in promoting financial inclusion & socio-economic justice
- the use of innovative business practices to combat financial exclusion
- the use of innovative technology and artificial intelligence to curb socio-economic justice challenges
- to big to fail theory, business rescue, good corporate governance measures & corporate insolvency challenges 6
- business & economic recovery strategies versus the promotion market integrity, public investor confidence and market efficiency in global financial markets
- Consumer protection, financial literacy and financial education challenges
