



DRAFT INTEGRATED WASTE MANAGEMENT BY-LAWS

The Draft Integrated Waste Management By-Law is the department's attempt into ensuring that the Municipality has an effective law supported by infrastructure to maximize recycling, minimize waste and protect the environment, promote the conservation of sensitive ecosystems and green infrastructure as well as ensuring good public health standards.



HOW FAR ARE WE WITH THE REVIEW OF THE BY-LAWS?

- Draft Integrated By-laws drafted in-house & have been Greened.
- Submitted to Corporate Legal Services on a project for the Review and Rationalization of the existing By-laws across EMM.
- Rationale of the project is to conduct an overhaul review, re-drafting, repel and rationalisation of all EMM By-Laws to ensure that all the EMM By-laws:
 - Are crafted within the context of EMM constitutional obligations as contained in Sections 152 and 153 of the Constitution as well as in other local government legislation which were passed to give effect to these provisions;
 - Are aligned with applicable provincial, national and international law applicable to local government;
 - Reflect the values espoused by the Constitution and applicable international instruments such as the United Nations and Regional Covenants and Conventions as well as other international Agreement;
 - Are in compliance with the applicable provincial and national policies adopted to address a particular (service delivery) issue/s or challenge/s;
 - Aligned to current trends, locally, nationally and internationally; and
 - take into consideration the effect and impact of case law.



SOLID WASTE BY-LAWS 2002

Council approval in 2002, therefore approved 7 years before NEMWA and are 14 years old in 2016.

Why the need to review and develop Integrated By-Laws

A number of new or pending legislation that have come online since 2002 (incl, the Waste Act) warrant the EMM to review, revise and amend the Solid Waste By-Laws of 2002.

And develop an integrated by-law that will enable EMM to:

 Regulate Waste Management Activities in terms of the Waste Hierarchy i.e. Avoidance, Minimisation, Processing & treatment, and final safe Disposal of waste

With the aim of ensuring sustainable waste management practices that limit and reduce the impact of poor waste management practices on the municipal environment and its people.



HOW WILL THE REVIEW OF THE SOLID WASTE BY-LAWS BENEFIT EMM?

- The review, revision and amendment of the Solid Waste By-Laws will empower the Municipality to:
 - Provide for an integrated waste management by-law which will necessitate for an integrated approach on all waste management and related activities with the EMM;

 Generally and uniformly regulate and control waste management activities within the EMM; and

Ensure that the regulation and control of waste management activities within the EMM is consistent and continues to comply to national and provincial legislative requirements.



WHAT WILL BE ACHIEVED WITH THE REVIEW OF THE CURRENT SOLID WASTE BY-LAWS?

- The EMM will be able to:
- Ensure alignment with current legislative developments;
- Provide for institutional arrangements and planning matters;
- Provide for specific waste management measures;
- Provide for the licensing and control of waste management activities;
- Provide for the remediation of contaminated land (illegal dumping);
- Provide for waste information management system;
- Provide for compliance monitoring and enforcement; and
- Provide for any matters connected therewith.

DRAFT INTEGRATED WASTE MANAGEMENT BY-LAWS

To provide for integrated waste management and matters incidental thereto

PRE-AMBLE

WHEREAS the Council has the Constitutional obligation to provide services including refuse removal, collection and disposal;

AND WHEREAS the National Environmental Management Act. 1998 (Act 107 of 1998) gives effect to the constitutional right aimed at protecting the environment by providing environmental management principles that apply throughout the Republic to the actions of all organs of state that may significantly affect the environment;

AND WHEREAS the National Environmental Management: Waste Act. 2008 (Act 59 of 2008) acknowledges that waste management practices in many areas of the Republic are not conducive to a healthy environment and that sustainable development requires that the generation of waste is avoided, or where it cannot be avoided, that it is reduced, re-used, recycled or recovered and only as a last resort treated and safely disposed of to ensure that the environment is protected from the negative impacts of poor waste management practices!

AND WHEREAS poor waste management practices can have adverse impacts on the environment in and beyond Municipal boundaries;

AND WHEREAS the Council is committed to ensuring that all residents, organisations, institutions, businesses, visitors or tourist and public bodies are able to access services from a legitimate waste service provider;

AND WHEREAS the Council wishes to regulate waste collection, separation, storage, processing, treatment, recycling, reuse and disposal; as well as littering, illegal dumping facilities used for the management of waste, with the ultimate aim of avoiding or minimising the generation and impact of waste;

AND WHEREAS the Council promotes the waste hierarchy approach as outlined in the National Waste Management Strategy;

CHAPTER 9: ENFORCEMENT OF THESE BY-LAWS AND AUTHORISED OFFICIALS

50. Enforcement

(1) The Municipality must appoint suitably qualified authorised officials for the enforcement of these By-laws.

(2) An authorised official must, upon appointment, be issued with an identification document by the Council which must state the name and designation of that official, and include a photograph of the official.

(3) An authorised official, exercising his powers or performing his functions and duties for the purposes of these By-laws, must present an identification document issued in terms of subsection (2) on demand by a member of the local community.

- 51. Powers of authorised officials
- (1) In addition to the powers, functions and duties an authorised official has by virtue of his appointment as such, an authorised official may, with the consent of the owner or person in charge of a vehicle or other mode of conveyance, search that vehicle or other mode of conveyance found in any place.
- (2) If consent is not obtained in terms of subsection (1), a vehicle or other mode of conveyance may be searched or stopped and searched, only pursuant to a valid written authorisation issued by a magistrate

(3) (a) If, in the opinion of an authorised official, any search of a vehicle or other mode of conveyance in terms of subsection (1) or (2), gives rise to the reasonable apprehension that the presence of waste in or on such vehicle or other mode of conveyance is a serious and immediate danger to human health or to the environment, the authorised official must instruct the owner or person in control of the vehicle concerned in writing to take the steps specified in that instruction which, in the opinion of such official, are necessary to mitigate harm to human health or damage to the environment.

(b) In the event of a refusal or failure to comply with an instruction given in terms of paragraph (a), the authorised official may report the matter to the Ekurhuleni
